3. Exemption claims will only be considered for the stated pre-approved / recognised qualifications.
4. The application fee of HK\$200 is non-refundable.
5. Only successful application will be charged for exemption fees.
6. Exemption results will normally be given in writing within two months after the receipt of application and supporting documents. If further assessment is needed due to unexpected circumstances, separate notifications will be given. The decision of the Institute is final and cannot be appealed.
7. All documents submitted will not be returned regardless of the result of the application.
8. The Institute reserves its right to refuse application for exemption if deemed appropriate.
