Overview

To promote greater collaboration and mobility of talent between Hong Kong and Macao, the Hong Kong Monetary Authority ('HKMA') and the Monetary Authority of Macao ('AMCM') signed a Memorandum of Understanding ('MOU') on 26 October 2018 in Macao to jointly promote and mutually recognise localized professional training and certifications under the Enhanced Competence Framework (ECF).

Under the MOU, HKIB is designated to administer several professional areas under the ECF in collaboration with the Macau Institute of Financial Services ('MIFS'). The ECF on Anti-Money Laundering and Counter-Financing of Terrorism (AML/CFT) at core level is the first localised ECF programme to be launched in Macao in March 2019.

Programme Objectives

This programme aims to equip candidates with the core competence in respect of Anti-Money Laundering and Counter-Financing of Terrorism required under the Enhanced Competency Framework (ECF), the banking industry standard introduced by the Hong Kong Monetary Authority (HKMA), as well as the local requirements set by the Monetary Authority of Macao (AMCM).

Assessment

Examination of 2.5 hours in Multiple Choice format.

Entry Requirements

Candidates of the Certified Banker (Stage I) - Macao must be HKIB Individual Members and fulfill one of the following minimum entry requirements:

- A Bachelor's Degree in any discipline awarded by a recognised university or equivalent; OR
- An Associate Degree (AD)/Higher Diploma (HD) in a banking and finance discipline or equivalent; OR
- Mature applicants with either:
 - At least five years of banking and finance work experience; OR
 - Two years of banking and finance work experience with a recommendation from their employer.
