Jointly organised with the Financial Dispute Resolution Centre (FDRC), this seminar focuses on establishing effective complaints handling and redress mechanisms to address customer complaints fairly, consistently, and promptly. In compliance with the licensing conditions of Authorized Institutions (AIs) and the Hong Kong Monetary Authority's Supervisory Manual IC-4 paragraph 1.1, AIs should actively consider subscribing to independent mediation and arbitration services. The seminar will outline AIs' responsibilities upon receiving mediation fee notifications, provide guidance on preparation, and clarify what to expect during mediation to ensure effective dispute resolution.
